#### **Management Systems**

#### Quality

**EcoProducts** ensures consistent quality that conforms to international food grade standards. EcoProducts is HACCP certified and has implemented an ISO 22 000 management system. Baobab powder and oil undergo routine quality checks at various critical control points. Microbiology, moisture content and colour are monitored. All processing, extraction and packaging takes place at **EcoProducts** premises. Processing time from fruit cracking to final sealed product is 1-2 days. This guarantees a light-coloured powder with a fresh tangy-sweet taste and a 3-year shelf-life.

#### Traceability

**EcoProducts** sources its baobab fruit directly from harvesters at village level. Their track and trace system follows the movement of the products from harvester to packed product.

## **Corporate Social Responsibility**

**EcoProducts** believes in making a positive impact on society and the environment. Raw material is sourced ethically, fairly and sustainably. Workers are treated with dignity. **EcoProducts** complies with all relevant environmental and labour laws in South Africa. # Products.....

#### **Organic Baobab Powder**

Baobab powder is made from baobab fruit. It is a naturally dried powder with a sweet-tangy taste. It is categorized as a food or superfruit and is used on its own or as an ingredient in health bars, beverages, ice-creams and baking. It has high concentrations of Vitamin C, calcium, magnesium, potassium and dietary fibers. It is known for its antioxidant and prebiotic properties.

### Organic Baobab Oil

Baobab oil is made from cold-pressing baobab seeds. It is a triglyceride fat which is liquid at room temperature. It is used in cosmetic products as an emollient and skin and hair conditioner. It is an excellent moisturizer known not to clog pores due to its small molecule size. It contains high concentrations of Omega 3, 6 and 9 fatty acids.

# Background to EcoProducts

**EcoProducts** was established by Dr. Sarah Venter in 2006. Commercial operations began by selling bulk baobab oil to the cosmetics industry and bottled baobab oil directly to the retail sector. In 2012 **EcoProducts** built a small baobab powder processing facility and started supplying bulk baobab powder to the food industry. In 2015 demand grew substantially resulting in **EcoProducts** moving its operations to larger premises. **EcoProducts** has been certified organic since 2006 and its food facility gained HACCP certification in 2015.
