• improve **active participation of IP&LCs** in negotiations of benefit-sharing agreements / management of sustainable biodiversity-based value chains



Overview – current implementation

Output 1: New concepts for the implementation of sharing the benefits arising from the use of biological resources are provided for the international discussion in the context of the Global Biodiversity Framework.

Output 2: Multi-stakeholder partnerships between providers and users of selected biological resources have been established.

Output 3: Capacities of national and regional actors have been strengthened in order to integrate research and development, BioTrade and the use of biological resources and fair benefit-sharing into national trade and economic policies.

Output 4: The participation of indigenous peoples and local communities in the negotiation of benefit-sharing agreements and the management of sustainable biodiversity-based value chains has improved.

Project Objective: Support biodiversity-based, African-European value chains and foster social-ecological change through developing mutually beneficial business partnerships based on high ethical, social and environmental standards, including equitable benefit-sharing.

- Commissioned by: Federal Ministry for Economic Cooperation and Development (BMZ)
- Partner countries: Cameroon, Namibia, South Africa, Madagascar
- Duration Phase I + II : 07/2019 to 12/2025

Partnership approach Companies SMMEs & Producers

Partnership approach of actors of transnational, biodiversity-based value chains (VCs):

- from raw material producers to processors to manufacturers of end products
- Increasing demand for biodiversity-based products with high ethical and ecological standards on the (European) market is the starting point for the partnerships
- Triple win: rural development through green jobs/income, promotion of a sustainable private sector, (re-)investment in the conservation of biodiversity and livelihoods
