# A sustainable success

The first African Biotrade Festival (ABF) - supported by the Swiss, German and South African governments - was a great strategic and commercial success. Feedback from the biotrade sector, government and small businesses has been overwhelmingly positive and there is broad support for the event to be sustained and expanded.

The ABF featured six pavilions dedicated to high-potential biotrade species and their sector organisations, and one specialist pavilion to showcase biotrade research, testing and standards. The species on show included Baobab, Marula, Buchu, Sceletium, Honeybush and various indigenous species used for essential and vegetable oils.

Also on show were more than thirty small businesses supported by the ABF funders, which joined 100 other Organic & Natural Products Expo Africa exhibitors, promoting their indigenous plant-based products and ingredients. Exhibitors and delegates represented countries including Botswana, Zimbabwe, Namibia, Cameroon, Madagascar and Côte D'Ivoire.

Held in Johannesburg from 14 to 16 September 2023, in partnership with the 2nd Organic & Natural Products Expo Africa (O&N), the festival attracted more than 4,000 visitors including 550 dedicated registrations for the ABF.

The African Biotrade Festival was organised by the ABioSA and BioInnovation Africa projects in partnership with the SA Department of Forestry, Fisheries and the Environment (DFFE), and the Department of Trade, Industry and Competition (dtic). ABioSA is funded by SECO and implemented by GIZ; and BIA is funded by the German government through the German Federal Ministry for Economic Cooperation and Development (BMZ).

Technical partners for the event included SIPPO, SSAIP, UNIDO GQSP, SANBI, GEF-6 and BioPANZA. Other key collaborators included the African Baobab Alliance, Buchu Association, SA Honeybush Tea Association, Southern African Botanical Products Association, Medical Research Council and the Southern African Essential Oils Producers Association.

Among many highlights at the event was the historic signing of an Access and Benefit-Sharing (ABS) agreement between the Buchu Association, the SA government represented by DFFE, the National Khoi Council and the South African San Council.

A dynamic two-day ABF conference programme included a government session to showcase the enabling environment for the biotrade, and an industry session to discuss industry's role and needs in a flourishing sector. There were talks on intellectual property, case studies about the Baobab and Marula sectors, and a discussion about equitable community involvement in the Honeybush sector.





Six students were given the opportunity to present their research, which included health and medical benefits of biotrade species, modelling of efficient oil extraction, environmental sustainability and community cultivation methods.

Also at the festival was a popular tasting experience featuring indigenous Honeybush and Rooibos teas. Biotrade producers and manufacturers have traditionally had to travel at great expense to international trade shows to showcase their products; but the African Biotrade Festival has now established itself as a powerful domestic event which contributes to an economically sustainable and equitable biotrade sector.

- The African Biotrade Festival has come a long way from the initial discussions on paper as part of the SECO funded ABioSA phase II project planning in 2020/21 between the partners.
- It has been pleasing to see robust and committed sector organisations at the pavilions dedicated to key species, and the vital support infrastructure provided by research, testing and standards which is an outflow from the six Sector Plans developed and now implemented through an intensive stakeholder engagement process facilitated by the ABioSA project.

- In 2019, the Rooibos sector signed the world's first industry-wide Benefit-Sharing Agreement recognising the KhoiKhoi and San people as the holders of Rooibos traditional knowledge.
- The multi-stakeholder ABS Capacity Development Initiative supported this process.
- We will be witnessing the second industry-wide Benefit-Sharing Agreement tonight.
- GIZ SA is hosting and implementing two biotrade projects, being the SECO funded ABioSA and BMZ funded BioInnovation Africa (BIA). These two projects are complementary to each other, where ABioSA focuses on a supply/"bottom-up" approach of supporting SMMEs to access new local and international markets while ensuring local communities share in the benefits; BIA focuses on a demand/"top-down" approach through supporting the African and European private sectors to develop mutually beneficial business partnerships based on ethical, social and environmental standards, including equitable benefit-sharing and the sustainable use of genetic resources.
- These projects are important in supporting the German 2030 agenda in building inclusive societies, sustainable value chains and contributing to climate change adaptation.
- This project naturally lends itself to respond to key quality criteria dealing with human rights and gender equality. Women are driving the natural products industry all the way from policy making, planting and harvesting, to processing, value adding, sales and marketing. Although their voices may not always be heard, the BIA project would like to contribute to making their voices louder in the second phase that started in January 2023.
